PATROL OPERATIONS DIVISION

Captain Troy Aronhalt

Patrol Operations is comprised of 16 sworn officers under the leadership of a Captain. Officers are assigned to one of four squads, each led by a Sergeant, working 12-hour shifts. Patrol Operations handles all dispatched calls for service, conducts self-initiated enforcement activities and provides high visibility patrols in hopes to prevent and deter criminal activity.

STAR Corridor Update

Officers handled **25** calls for service in this area; completed **89** park, walk and talk activities as well as **46** hours of traffic enforcement and general observation time. Officers had **134** community contacts and conducted **6** roll call meetings.

Patrol Highlights

On April 3, officers conducted a traffic stop in the 500 block of Washington Hwy. The driver was subsequently arrested for DUI.

On April 5, officers conducted a traffic stop on a vehicle in the 700 block of N. Washington Hwy. The driver was arrested for DUI, refusal, and outstanding warrants.

On April 7, after an extensive investigation, a patrol officer obtained a preservation order, nondisclosure agreement, search warrant, and multiple arrest warrants related to car larcenies in the town.

On April 8, officers responded to the 100 block of S. Hill Carter Pkwy for a shoplifter. The subject was arrested for shoplifting as well as an outstanding felony warrant for fraud.

On April 18, officers responded to a local hotel to investigate a drug complaint. Their investigation resulted in multiple drug arrests to include possession of narcotics.

On April 21, officers responded to a possible intoxicated driver in the 100 block of Thompson St. After investigating, the driver was arrested for DUI and two counts of assault on law enforcement.

SPECIAL OPERATIONS DIVISION

Under the command of Special Operations Division, the **Investigative Unit** is comprised of three investigators led by Lt James Shelhorse. This operational component is responsible for the investigation of all felony and serious/repeat misdemeanor offenses reported to the police department. Additionally, this unit is tasked with proactive investigations into narcotics trafficking and other criminal behavior.

Investigative Highlights

Investigators responded to the Red Roof Inn to assist with a manufacturing of narcotics situation.

Investigators responded to assist with a double overdose in which two individuals were hospitalized. Children were present during the overdose incident therefore investigators obtained criminal charges for the parents. Children were placed with family members.

Investigators continued to review records returns for electronic evidence received in the Burgos homicide case.

Investigators attended the preliminary hearing for the Burgos homicide case. Grand Jury is set for May 21st.

Investigators followed up on a situation related to the Burgos homicide in which a witness was being intimidated. Two felony warrants were obtained for the suspect and he was arrested. Currently he is still incarcerated.

Investigators were assigned multiple Child Abuse Response Team referrals in which only 1 was founded and an arrest was made. Investigators utilized the CAC for intensive interview in one of the unfounded cases.

Investigators assisted patrol units with two separate fraud cases.

Investigators are currently still working a case in which multiple bullets were fired from an unknown person into an occupied dwelling. There were no injuries during the incident..

Investigators attended CART and SART monthly meetings as well as Grand Jury and conducted K-9 training for the patrol division.

Under the command of the Special Operations Division, the **Crime Prevention/Logistics Unit** entails several functional components of the agency: Crime Prevention (1 officer), and the Auxiliary Unit (3 volunteer officers) and civilian volunteers all led by Sgt. Marie Kemp. In addition to duties tasked to individual members, this component is responsible for Recruitment, Selection, Training, Public Information, Special Event Coordination, and IT Administration.
