



## Town of Ashland Outdoor Festival Permit

According to Town Code 9-55, “*No person shall stage, promote or conduct any parade, musical or entertainment festival in the Town unless there shall have been first obtained from the Town a special entertainment permit for such festival or parade.*”

The purpose of this regulation process for festivals and parades is to ensure the public health, safety and welfare of the citizens of the Town, and those attending the function.

**As a rule of thumb, an event will require a permit if amplified music is involved and there are over 50 people planned to be in attendance.**

The festival permit process does not apply to the following:

- Any event that is completely held within an enclosed, permanent, structure;
- Any such gathering conducted within the confines of a family, theme or recreation park, wherein nonmusical entertainment is provided on a regular basis;
- Wedding receptions
- The playing of non-amplified instruments

It is important to note that approved events must also comply with the noise ordinances, specifically that amplified audio cannot be operated between the hours of 11:00pm and 7:00am (Section 10.1-5.1).

\* The completed application must be filed **21** days before the date of event to the Ashland Police Department.

### **NOTE:**

Security must be provided for 50 or more people and must be approved by the Chief of Police (Section 12-10.1).

**A PERMIT REQUIRED BY THIS ARTICLE SHALL NOT BE ISSUED, UNLESS THE FOLLOWING CONDITIONS ARE MET AND THE FOLLOWING PLANS, STATEMENTS, APPROVALS AND OTHER DOCUMENTS ARE ATTACHED TO THE PERMIT APPLICATION:**
