PATROL OPERATIONS DIVISION

Patrol Operations is comprised of 16 sworn officers under the leadership of **Major Troy Aronhalt.** Officers are assigned to one of four squads, each led by a Sergeant, working 12-hour shifts. Patrol Operations handles all dispatched calls for service, conducts self-initiated enforcement activities and provides high visibility patrols in hopes to prevent and deter criminal activity.

STAR Corridor Update

Officers handled **10** calls for service in this area; completed **36** park, walk and talk activities as well as **17** hours of traffic enforcement and general observation time. Officers had **22** community contacts and conducted **6** roll call meetings.

Patrol Highlights

On August 10, officers responded to a reported domestic situation in the 200 block of Secretariat Court. Upon conclusion of the investigation, a male subject was arrested for domestic assault.

On August 11, officers responded to the 200 block of North Washington Highway regarding a shoplifting call. Officers located and arrested the suspect for public intoxication.

On August 21, officers responded to a call for a domestic disturbance in the 100 block of Thompson Steet. After officers conducted an investigation into the domestic disturbance, the subject was charged with strangulation.

On August 24, officers stopped out with a suspicious subject in the 800 block of England Street. Upon interviewing the subject, it was discovered the subject was wanted. He was placed under arrest for a probation violation.

On August 25, officers responded to a serious crash involving a single vehicle in the area of North Washington Highway and Omni Drive. Officers found the driver deceased and the passenger with life threatening injuries. Officers from the crash team have conducted an investigation and determined speed was a major factor in the collision.

On August 29, officers responded the 900 block of Thompson Street for an assault. After completing an investigation, a warrant was obtained and served on the suspect for assault.

SPECIAL OPERATIONS DIVISION

Under the command of Special Operations Division, the **Investigative Unit** is comprised of three investigators led by **Capt. James Shelhorse**. This operational component is responsible for the investigation of all felony and serious/repeat misdemeanor offenses reported to the police department. Additionally, this unit is tasked with proactive investigations into narcotics trafficking and other criminal behavior.

Investigative Highlights

Investigators continued their investigation this month into a series of catalytic converter thefts that have impacted the town and surrounding jurisdictions. Investigators continue to work with other agencies sharing valuable information.

Investigators responded to two complaints of child abuse. One was unfounded and the other was found to have occurred in another jurisdiction. Information was forwarded to the appropriate agency for investigation.

Investigators were assigned several fraud complaints throughout the month. Investigators have submitted search warrant records requests to multiple financial institutions reference these cases.

Investigators responded for a breaking and entering at Carter Park Pool. There were extensive efforts made to identify a suspect however there have been no leads in this case. Forensic processing of the scene revealed some minor evidence which is being analyzed currently.

Investigators were assigned to follow-up on a possible assault. The female victim was located at the hospital with significant injuries. Arrest warrants for attempted murder, malicious wounding and strangulation were obtained. Investigations and patrol officers worked together to arrest the subject without incident.

Investigators assisted with a report of an individual firing a gun in the air near the area of 214 Randolph Street. An individual was identified through citizen cooperation and video surveillance and an arrest was made for one of the suspects in the vehicle from which the shot was fired.

SPECIAL OPERATIONS DIVISION

Under the command of the Special Operations Division, the **Crime Prevention/Logistics Unit** entails several functional components of the agency: Crime Prevention (1 officer), and the Auxiliary Unit (1 volunteer officers) and civilian volunteers all led by **Capt. Marie Kemp**. In addition to duties tasked to individual members, this component is responsible for Recruitment, Selection, Training, Public Information, Special Event Coordination, and IT Administration.
